

**FY 2023 Continuum of Care (CoC) Program Competition NOFO**  
**CoC Estimated Annual Renewal Demand Report**

As stated in Section II.A of the FY 2023 CoC Program Competition NOFO, approximately \$3,134,000,000 is available in the FY 2023 CoC Program Competition, including at least \$52 million available for Domestic Violence (DV) Bonus projects and approximately \$147,000,000 million available for the competitive renewal and replacement of expiring Round 1 YHDP Grants and the non-competitive renewal and replacement of expiring grants YHDP grants initially funded in FY 2017 (Round 2) or later. HUD may add to the total amount with any available funds that have been carried over or recaptured from previous fiscal years. All requirements in the FY 2023 application process, including requirements for the entire CoC Consolidated Application and the total amount of funds available, are included in the NOFO.

The following Estimated ARD report that includes each CoC's Preliminary Pro Rata Need (PPRN) amount, Estimated ARD, Tier 1 based on estimated ARD at 93 percent (Section I.B.2.b.(1) of the NOFO), CoC Bonus (I.B.2.b.(3) of the NOFO), DV Bonus (Section I.B.2.b.(8) of the NOFO), CoC Planning (Section III.B.3.f.(9)(a) of the NOFO), and UFA Costs (Section III.B.3.f.(9)(b) of the NOFO). Round 1 YHDP Grants renewing competitively in the FY 2023 CoC Program competition are included in the Tier 1 calculation. However, YHDP grants initially funded in FY 2017 (Round 2) or later are excluded from the Tier 1 calculation.
