## Notice of Funding Opportunity Announcement

On November 13, 2025, the Department of Housing and Urban Development (HUD) announced the release of the Continuum of Care application for its competitive grants for housing and services for the homeless as defined by HUD. The Fall River Community Development Agency (CDA), acting as the Collaborative Applicant for the Fall River CoC (MA-515), is responsible to submit the CoC Collaborative Application including all new and renewal projects to the Department of Housing and Urban Development via esnaps by January 14, 2026, 8:00 p.m. EDT. This is a very short timeframe compared to previous submissions.

The Fall River CoC announces that the FY2025 Continuum of Care Competition for funding for housing and services for the homeless from the Department of Housing and Urban Development is open. **This year's local competition will require a Request for Proposals for new and renewal projects.**

### Funding Availability for Fall River MA-515

The FY2025 CoC Competition priorities have shifted, including a drastic reduction in Tier 1 from 90% last year to 30% this year, and a 30% cap on Permanent Supportive Housing Projects. The Fall River CoC PSH funding is currently at 87% of our annual renewal amount. Project grant term funding is for one year.

This is an open competition, and this funding opportunity is open to any eligible applicant regardless of if you have received CoC funding in the past (see attached for information on eligible applicants). **This competition is open to all eligible applicants.**

Please note that this year's 30% cap on PSH projects is due to a shift in HUD's priorities. The four components to be funded through this CoC Program Competition are:

- Transitional Housing;
- Supportive Services Only (including Coordinated Entry);
- Permanent Housing (including Rapid Rehousing) (capped at 30% including new and renewal projects); and
- Homeless Management Information System.
